

FLIGHT CENTRE TRAVEL EXPO SYDNEY 2026

CONDITIONS OF ENTRY

The Promoter

1. The promoter is Flight Centre Travel Group Limited trading as Flight Centre ("Promoter") of Southpoint, 275 Grey Street, South Brisbane QLD 4101, Australia. ABN 25 003 377 188.

Conditions of Entry

2. Eligibility information and the prize offered form part of these Conditions of Entry. An individual who makes a qualifying Booking (as set out in clause 7) is deemed to have accepted these Conditions of Entry.
3. Entry is open to residents of Australia aged 18 years or older who comply with the requirements set out in these Conditions of Entry ("Eligible Entrants").
4. Employees of Flight Centre Travel Group Limited, its related bodies corporate, Azamara, and their respective suppliers, agencies and licensees, and the immediate families of any of the foregoing, are not permitted to enter.

Duration of Promotion

5. The Promotion will open at 5:00pm AEDT on Friday 16 October 2026 and close at 5:00pm AEDT on Sunday 18 October 2026 ("Promotion Period").
6. The Flight Centre Travel Expo Sydney ("Expo") will be held on Friday 16 October 2026, Saturday 17 October 2026 and Sunday 18 October 2026 at ICC Sydney, Darling Harbour, Sydney NSW ("Expo Dates").

How to Enter

7. To enter, Eligible Entrants must, during the Promotion Period, make a travel booking and pay a deposit for that booking ("Booking"), with the deposit funds received and on file with the Promoter during the Promotion Period, either: (a) at the Expo (ICC Sydney); or (b) in person at any Flight Centre retail store located in New South Wales or the Australian Capital Territory. Entry will be automatic based on meeting the Prize eligibility.
8. One (1) entry will be recorded per Eligible Entrant, regardless of the number of qualifying Bookings made during the Promotion Period. No further sign-up, registration or action is required.
9. The Promoter does not accept responsibility for late, lost, incomplete or misdirected Bookings, or for any technical or administrative failure in recording deposit funds during the Promotion Period.

16. If the Prize is not claimed by this time, a first redraw will take place at 10:00am AEDT on Tuesday 17 November 2026 at the Promoter's Head Office (address above). The entrant drawn ("Redraw Winner 1") will be notified by telephone and/or email on the day of the redraw and will have until 5:00pm AEDT on Monday 30 November 2026 to claim the Prize.

21. The Prize is one (1) Ocean View Cabin for up to two (2) guests aboard the Azamara Pursuit's 14-Night Japan Intensive: Hiroshima, Aomori & Tokyo voyage, departing 6 May 2027, valued at approximately AUD\$19,178 ("Prize").
22. No alternative departure date, ship, itinerary or cabin category is available.
23. The Prize includes: complimentary AzAmazing Celebrations (on most voyages); select standard spirits, international beers and wines; gratuities; bottled water, soft drinks, specialty coffees and teas; self-service laundry; shuttle service to and from port communities, where available; and concierge services for personal guidance and reservations.

General

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, tampering, unauthorised intervention, fraud, technical failure or any other cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, subject to State or Territory regulation.
37. These Conditions of Entry shall be subject to the laws of Queensland, Australia and the relevant jurisdiction in which the Eligible Entrant entered the Promotion.
