CONDITIONS OF ENTRY

The Promoter

1. The promoter is Flight Centre Travel Group Limited trading as Flight Centre ("Promoter") of Southpoint, 275 Grey Street, South Brisbane QLD 4101, Australia. ABN 25 003 377 188.

Conditions of Entry

2. Eligibility information and the prize offered form part of these Conditions of Entry. An individual who attends the Canyon Spirit 'Scan to Win' stand at the Flight Centre Travel Expo Sydney during the Promotion Period and submits an entry is deemed to have accepted these Conditions of Entry.
3. Entry is open to residents of Australia aged 18 years or older who comply with the requirements set out in these Conditions of Entry ("Eligible Entrants").
4. Employees of Flight Centre Travel Group Limited, its related bodies corporate, Canyon Spirit, and their respective suppliers, agencies and licensees, and the immediate families of any of the foregoing, are not permitted to enter.

Duration of Promotion

5. The Promotion will open at 5:00pm AEDT on Friday 16 October 2026 and close at 4:00pm AEDT on Sunday 18 October 2026 ("Promotion Period").
6. The Flight Centre Travel Expo Sydney ("Expo") will be held on Friday 16 October 2026, Saturday 17 October 2026 and Sunday 18 October 2026 at ICC Sydney, Darling Harbour, Sydney NSW ("Expo Dates").

How to Enter

7. To enter, Eligible Entrants must, during the Promotion Period, physically attend the Expo and visit the Canyon Spirit 'Scan to Win' stand, where they must scan the QR code provided and complete the entry prompts ("Entry").
8. One (1) entry will be recorded per Eligible Entrant, regardless of the number of times an Entrant scans the QR code or visits the Canyon Spirit stand.
9. The Promoter does not accept responsibility for late, lost, incomplete or misdirected entries, or for any technical failure of the QR code or scanning system.
10. Any costs associated with attending the Expo are the responsibility of each entrant.

Selection of Prize Winner

11. There will be one (1) Prize Winner.

14. The Prize Winner will have until 5:00pm AEDT on Monday 16 November 2026 to claim the Prize.
15. If the Prize is not claimed by this time, a first redraw will take place at 10:00am AEDT on Tuesday 17 November 2026 at the Promoter's Head Office (address above). The entrant drawn ("Redraw Winner 1") will be notified by telephone and/or email on the day of the redraw and will have until 5:00pm AEDT on Monday 30 November 2026 to claim the Prize.

The Prize is one (1) three-day, all-daylight Canyon Spirit rail journey (Signature Experience) for two (2) adults on the Rockies to the Red Rocks route, between Salt Lake City, Utah and Denver, Colorado, valued at up to USD\$3,618 ("Prize"). The journey may be taken in either direction (eastbound or westbound).

The Prize includes: travel in a single-level glass dome coach; interactive storytelling and personalised service from Canyon Spirit Hosts; all-inclusive food and beverages onboard, including hot gourmet breakfast and lunch service and complimentary alcoholic beverages and snacks; overnight hotel accommodation in Moab, Utah and Glenwood Springs, Colorado; and rail station transfers, where applicable.
