

## **FLIGHT CENTRE TRAVEL EXPO SYDNEY 2026**

### **WIN A G ADVENTURES SERENGETI & ZANZIBAR TOUR FOR 2**

#### **CONDITIONS OF ENTRY**

##### **The Promoter**

1. The promoter is Flight Centre Travel Group Limited trading as Flight Centre ("Promoter") of Southpoint, 275 Grey Street, South Brisbane QLD 4101, Australia. ABN 25 003 377 188.

##### **Conditions of Entry**

2. Eligibility information and the prize offered form part of these Conditions of Entry. An individual who attends the G Adventures 'Scan to Win' stand at the Flight Centre Travel Expo Sydney during the Promotion Period and submits an electronic entry is deemed to have accepted these Conditions of Entry.
3. Entry is open to residents of Australia aged 18 years or older who comply with the requirements set out in these Conditions of Entry ("Eligible Entrants").
4. Employees of Flight Centre Travel Group Limited, its related bodies corporate, G Adventures, and their respective suppliers, agencies and licensees, and the immediate families of any of the foregoing, are not permitted to enter.

##### **Duration of Promotion**

5. The Promotion will open at 5:00pm AEDT on Friday 16 October 2026 and close at 4:00pm AEDT on Sunday 18 October 2026 ("Promotion Period").
6. The Flight Centre Travel Expo Sydney ("Expo") will be held on Friday 16 October 2026, Saturday 17 October 2026 and Sunday 18 October 2026 at ICC Sydney, Darling Harbour, Sydney NSW ("Expo Dates").

##### **How to Enter**

7. To enter, Eligible Entrants must, during the Promotion Period, physically attend the Expo and visit the G Adventures 'Scan to Win' stand, where they must scan the QR code and complete an electronic entry form or scan their entry Travel Expo QR code (which will automatically submit Entrant details) and complete the entry prompts ("Entry").
8. One (1) entry will be recorded per Eligible Entrant, regardless of the number of times an Entrant scans submits an entry.
9. The Promoter does not accept responsibility for late, lost, incomplete or misdirected entries, or for any technical failure of the QR code or scanning system.

##### **Selection of Prize Winner**

10. There will be one (1) Prize Winner.

13. The Prize Winner will have until 5:00pm AEDT on Monday 16 November 2026 to claim the Prize.
14. If the Prize is not claimed by this time, a first redraw will take place at 10:00am AEDT on Tuesday 17 November 2026 at the Promoter's Head Office (address above). The entrant drawn ("Redraw Winner 1") will be notified by telephone and/or email on the day of the redraw and will have until 5:00pm AEDT on Monday 30 November 2026 to claim the Prize.

15. If the Prize is not claimed by Redraw Winner 1 by this time, a second and final redraw will take place at 10:00am AEDT on Tuesday 1 December 2026 at the Promoter's Head Office (address above). The entrant drawn ("Redraw Winner 2") will be notified by telephone and/or email on the day of this redraw and will have until 5:00pm AEDT on Monday 14 December 2026 to claim the Prize.
16. If the Prize is not claimed by Redraw Winner 2 by this time, the Prize will be forfeited in its entirety. No further redraw will take place.

19. The Prize is one (1) G Adventures Classic Serengeti & Zanzibar tour (code DKWZ ) for two (2) guests, valued at approximately AUD\$11,798 ("Prize").
20. The Prize must be booked by 31 December 2026 and the first date of travel must be before 31 July 2027. No extension is available.
21. The tour must have four (4) or more paying passengers booked on it at the time of booking.
22. The Prize applies to the DKWZ itinerary only and excludes optional or additional services, including but not limited to: any airfare not expressly included in the itinerary, transfers, pre- or post-tour accommodation, "My Own Room" or "My Own Tent," insurance, amendments, vaccinations, and all incidentals, meals, gratuities, taxes, fees, levies, and transportation not expressly included in the itinerary.

All travel-related expenses, including but not limited to transportation to and from home, airfare, taxes, gratuities, incidentals, upgrades, insurance, service charges, airport surcharges, departure taxes, hotel, resort or property fees, food and beverage, and excursions not specifically included in the applicable trip itinerary, and personal expenses including but not limited to telephone/internet charges and gift shop purchases, are the sole responsibility of the Prize Winner.
24. The Prize cannot be exchanged, is non-transferable, non-refundable and cannot be exchanged or redeemed for cash.
25. The Prize cannot be used on existing bookings or in conjunction with any other discounts or special offers, and is subject to availability and confirmation by G Adventures at the time of booking.
26. The Prize Winner is responsible for obtaining all necessary valid travel documents (including passport and visa) and for complying with all health and other governmental regulations relevant to travel.

  - (d) the unavailability or inaccessibility of any service;
  - (e) unauthorised human intervention in any part of the Promotion;
  - (f) electronic or human error in the administration of the Promotion;
  - (g) any loss or damage to person or property arising in connection with the Prize; or

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, tampering, unauthorised intervention, fraud, technical failure or any other cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, subject to State or Territory regulation.
36. These Conditions of Entry shall be subject to the laws of Queensland, Australia and the relevant jurisdiction in which the Eligible Entrant entered the Promotion.
